INSTRUCTIONS FOR USE

Xiidra, a lymphocyte function-associated antigen-1 (LFA-1) antagonist, is indicated for the treatment of the signs and symptoms of **dry eye disease**.¹ The safety and efficacy of Xiidra in pediatric patients have not been established.

Guidelines

The American Academy of Ophthalmology (AAO) Dry Eye Syndrome Preferred Practice Pattern® (2024) notes dry eye syndrome is also known as dry eye disease or keratoconjunctivitis sicca.² Dry eye is generally classified according to both symptoms and signs (i.e., mild, moderate, or severe); however, there is an emphasis on symptoms over signs. Management of dry eye is listed as a four-step staged approach, but specific therapies may be chosen from any step, regardless of the level of disease severity, depending on provider experience and patient preference. Xiidra, as well as other FDA-approved therapies for dry eye disease (cyclosporine ophthalmic products, Miebo™ [perfluorohexyloctane ophthalmic solution], and Tyrvaya® [varenicline nasal spray]), and are noted as Step 2 options in the Preferred Practice Pattern. The AAO notes use of any of these FDA-approved products may lead to improvement of patient symptoms and/or signs but none has been proven more effective than the other in head-to-head trials; there are no direct comparisons in a prospective clinical trial in the literature.

Coverage Policy

POLICY STATEMENT

Prior Authorization is required for benefit coverage of Xiidra. All approvals are provided for the duration noted below.

Xiidra is considered medically necessary when the following are met:

FDA-Approved Indication

- **1. Dry Eye Disease.** Approve for 1 year if the patient meets BOTH of the following (A <u>and</u> B) <u>Note</u>: Examples of dry eye disease include dry eye syndrome and keratoconjunctivitis sicca.
 - **A.** Patient is ≥ 18 years of age; AND
 - **B.** Preferred product criteria is met for the product as listed in the below table

Individual and Family Plans:

Product	Criteria
Xiidra	ONE of the following (1 or 2):
(lifitegrast ophthalmic solution)	 The patient has tried, and according to the prescriber, has experienced inadequate efficacy OR significant intolerance with cyclosporine ophthalmic 0.05% emulsion; OR
	2. The patient is currently receiving therapy with Xiidra.

When coverage is available and medically necessary, the dosage, frequency, duration of therapy, and site of care should be reasonable, clinically appropriate, and supported by evidence-based literature and adjusted based upon severity, alternative available treatments, and previous response to therapy.

Receipt of sample product does not satisfy any criteria requirements for coverage.

Xiidra for any other use is considered not medically necessary, including the following (this list may not be all inclusive; criteria will be updated as new published data are available):

 Concomitant Use with an Ophthalmic Cyclosporine Product or Tyrvaya (varenicline nasal solution). There are no data to support the concomitant use of Xiidra with an ophthalmic cyclosporine product or Tyrvaya.
 Note: Ophthalmic cyclosporine products are Cequa, Restasis, and Vevye.
